As part of the recertification process, Fairburn successfully passed a rigorous GDOT LAP Audit for the Downtown LCI Streetscape Project (P.I. # 0012636 - SR 14; CS 4130/W Campbellton Road & CS 4050/Smith Street-LCI) conducted on March 27, 2024. Passing this audit, which is conducted randomly and can be a daunting challenge for many municipalities, further validates Fairburn's readiness and capacity to handle complex, high-stakes projects.

Failure to pass such audits could have resulted in the repayment of critical state and federal funding, amounting to approximately \$5 million for the Downtown LCI Streetscape Project and an anticipated \$125 million for the forthcoming I-85 at SR 74 Interchange Project. Fairburn's successful audit is a clear indicator of the City's preparedness and steadfast commitment to accountability.

"This recertification is not just a validation of our processes but a shield protecting the significant investments we are making in Fairburn's future," said Tony M. Phillips, City Administrator. "With this authorization, we are fully equipped to move forward with confidence, knowing that we have the tools, the expertise, and the trust of GDOT to deliver on projects that are crucial to our city's continued success."
